Seminars will be in-person synchronous – students can attend class in-person or virtually through a videoconference platform.

The University is investigating a blend of online and live course delivery, and is being guided by recommendations from health authorities and the provincial and federal governments. Course Description:

This course will examine the foreign relations of the People's Republic of China from its inception in 1949 through to the present day. The focus of the course will be on China's political and security relations with global powers, including the Soviet Union/Russian Federation, Japan, India, Iran, and the USA.

Prerequisite(s):

2.0 courses in History at the 2200 level or above.

Unless you have either the prerequisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. The decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

Course Syllabus:

Living in this world means understanding that China is a part of it, and that China – its people, government, banks, armed forces – have a seat at the proverbial table. Students enrolled in this course will examine international relations from the Chinese perspective. They will be tasked with explaining

how world events of the latter part of the 20th and the early 21st century were been shaped by Chinese influence, and how China adapted to international challenges.

Course Materials:

John W. Garver, *China's Quest: The History of the Foreign Relations of the People's Republic of China*, Oxford University Press, 2018.

Podcasts, to be assigned on a weekly basis.

Methods of Evaluation:

Essay Proposal (10%): Due September 30.

The essay proposal defines the essay topic, establishes the research question and preliminary thesis, and briefly outlines the draft Research Essay (see below).

This is a required component and must be completed before submitting the Annotated Bibliography (see below).

Annotated Bibliography (10%): Due October 28

The annotated bibliography will be the second step in writing the capstone term paper for the course. Once the student determines the essay topic in consultation with the professor, they will compile a bibliography of ten to fifteen texts (books and academic articles) that relate to the same topic. Each entry is to be accompanied by a paragraph that briefly outlines the position of the author and describes how the text relates to the essay topic.

This is a required component and must be completed before submitting the Research Essay (see below)

Research Essay (50%): November 25

As the capstone assignment for the course, the Research Essay develops the Annotated Bibliography into a comprehensive historiographical discussion and develops the Essay Proposal into a fully articulated scholarly discussion of 20 pages in length.

This is a required component and must be completed to pass the course.

Essay Presentation (10%): December 2

The last class of the term will be treated as a symposium in which students deliver a “3 minute thesis” based on their research papers. Students will be graded on both content and delivery.

Professionalism (20%)

This is not a lecture course. Students are expected to arrive in class fully prepared, and to make ongoing contributions to the discussion. To reinforce the atmosphere of professionalism, equal portions of the Professionalism grade will be assigned to attendance, preparation (judged on the basis of a short weekly quiz), and participation. Unexcused absences will result in a score of 0 for the week in question.

Accommodation for missed midterms with a Self Reported Absence:

Students with an approved absence from an in-class test will be required to write a makeup test on one of the two time slots available in each term:

Fall Term

- Tests scheduled before November 1 – the makeup will take place Monday, November 9 at 9:30am.
- Tests scheduled between November 9 and December 3 – the makeup will take place Friday, December 4 at 12:30pm.

Winter Term

- Tests scheduled before February 13 – the makeup will take place Monday, February 22 at 9:30am.
- Tests scheduled between February 22 and April 1 – the makeup will take place Friday, April 2 at 12:30pm

No other make-up opportunities will be provided. Students who fail to write a makeup test in the designated time slots will receive a grade of zero.

Students in online courses will write the make-up test through OWL over a 24-hour period beginning at the time noted above.

Students should be aware that course professors may not be available to respond to questions during the makeup test slots.

Accommodation for missed assignment deadlines with a Self Reported Absence:

If a student reports a SRA for an assignment (i.e. an essay) the new due date will be 48 hours after the SRA was submitted. For example, if you complete a SRA on March 19 at 3pm, your new due date will be March 21 at 3pm.

Plagiarism:

Students must write their essays and assignments in their own words. Whenever students take an idea, or a passage from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major academic offense (see Scholastic Offence Policy in the Western Academic Calendar).

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<http://www.turnitin.com>).

Students are expected to retain all research notes, rough drafts, essay outlines, and other materials used in preparing assignments. In the unlikely event of concerns being raised about the authenticity of any assignment, your instructor may ask you to produce these materials; an inability to do so may weigh heavily against you.

The following rules pertain to the acknowledgements necessary in academic papers.

A. In using another writer's words, you must both place the words in quotation marks and acknowledge that the words are those of another writer.

You are plagiarizing if you use a sequence of words, a sentence or a paragraph taken from other writers without acknowledging them to be theirs. Acknowledgement is indicated either by (1) mentioning the author and work from which the words are borrowed in the text of your paper; or by (2) placing a footnote number at the end of the quotation in your text, and including a correspondingly numbered footnote at the bottom of the page (or in a separate reference section at the end of your essay). This footnote should indicate author, title of the work, place and date of publication and page number. Method (2) given above is usually preferable for academic essays because it provides the reader with more information about your sources and leaves your text uncluttered with parenthetical and tangential references. In either case words taken from another author must be enclosed in quotation marks or set off from your text by single spacing and indentation in such a way that they cannot be mistaken for your own words. Note that you cannot avoid indicating quotation simply by changing a word or phrase in a sentence or paragraph which is not your own.

B. In adopting other writer's ideas, you must acknowledge that they are another writers ideas.

You are plagiarizing if you adopt, summarize, or paraphrase other writers' trains of argument, ideas or sequences of ideas without acknowledging their authorship according to the method of acknowledgement given in "A" above. Since the words are your own, they need not be enclosed in quotation marks. Be certain, however, that the words you use are entirely your own; where you must use words or phrases from your source; these should be enclosed in quotation marks, as in "A" above.

Clearly, it is possible for you to formulate arguments or ideas independently of another writer who has expounded the same ideas, and whom you have not read. Where you got your ideas is the important consideration here. Do not be afraid to present an argument or idea without acknowledgement to another writer, if you have arrived at it entirely independently. Acknowledge it if you have derived it from a source outside your own thinking on the subject.

In short, use of acknowledgements and, when necessary, quotation marks is necessary to distinguish clearly between what is yours and what is not. Since the rules have been explained to you, if you fail to make this distinction, your instructor very likely will do so for you, and they will be forced to regard your omission as intentional literary theft. Plagiarism is a serious offence which may result in a student receiving an 'F' in a course or, in extreme cases, in their suspension from the University.
