COURSE DESCRIPTION

Epidemics and pandemics exert lasting influence upon demography, community practices and individual lives. With a focus from the early 19th century to the present, this course investigates the impact of disease outbreaks as well as the social and scientific responses to them. Topics will include the role of governments and the increase in (self)surveillance of health; the interaction of technological advance and epidemic disease; social inequality and colonial regimes in relation to disease events; and the interactions of age, race and gender with public health challenges; and the legacy of COVID-19 in historical perspective.

COURSE DELIVERY:

The main course platform (except the final exam) is online and

asynchronous. All required course materials will be available online either through OWL or through the Weldon Library website.

COURSE SYLLABUS

In this class students will build the following competencies and skills:

- Identify and describe key events and concepts in the history of pandemics from the nineteenth century to the present
- Understand the interdisciplinary nature of investigation in this field of inquiry
- Evaluate diverse forms of historical evidence and cultivate interpretive skills
- Strengthen writing skills with attention to composition strategies for history
- Consider recent pandemic threats and current challenges
- Engage with faculty and peers in a collaborative, respectful atmosphere

METHODS OF EVALUATION

Students must submit all written assignments and complete the exam to pass the course.
